## OVERSIGHT BOARD RESOLUTION NO. 125-18-OB

RESOLUTION OF THE OVERIGHT BOARD TO THE SUCCESSOR AGENCY TO THE SUNNYVALE REDEVELOPMENT AGENCY GIVING DIRECTION TO THE SUCCESSOR AGENCY STAFF REGARDING THE HIRING OF ADDITIONAL LEGAL COUNSEL AND AUTHORIZING THE OVERSIGHT BOARD CHAIR TO REQUEST AN EXTENSION TO ANSWER COUNTY OF SANTA CLARA ET AL V. SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY SUNNYVALE ET AL, SACRAMENTO SUPERIOR COURT CASE NUMBER 34-201880002837

WHEREAS, the Oversight Board to the Successor Agency to the Sunnyvale Redevelopment Agency ("Oversight Board") has been named as a Respondent in the certain lawsuit titled *County of Santa Clara et al. v. Successor Agency to the Redevelopment Agency of the City of Sunnyvale et al*, Sacramento Superior Court Case Number 34-2018-80002837 ("Litigation") which was filed on March 20, 2018, and served on March 22, 2018; and

WHEREAS, the Oversight Board's response to the Litigation is due on April 22, 2018 unless the Oversight Board obtains an extension to respond from the Petitioners in the Litigation; and

WHEREAS, the Oversight Board is not represented by an attorney; and

WHEREAS, the Oversight Board desires to take the following actions in response to the Litigation.

NOW, THEREFORE, BE IT RESOLVED BY THE OVERSIGHT BOARD TO THE SUCCESSOR AGENCY OF THE FORMER REDEVELOPMENT AGENCY OF THE CITY OF SUNNYVALE THAT:

- 1. The Oversight Board authorizes the Chair of the Oversight Board to request an extension to respond to the Litigation for 45 days after the Department of Finance makes a determination on Resolution No. 122-18-OB; and
- 2. The Oversight Board, in accordance with Health and Safety Code Section 34179(n) directs the Successor Agency to provide legal representation to the Oversight Board for the Litigation and directs the Successor Agency to follow the following procedures for obtaining legal representation for the Oversight Board:
  - a. Obtain proposals from attorneys for the Oversight Board representation to be presented to the Oversight Board for selection of the attorney; and

3. The Oversight Board directs the Successor Agency to explore options with the Department of Finance for amendments to the Successor Agency's Recognized Obligation Payment Schedule to provide funding for the Oversight Board's legal representation.
