Project Overview

Project Location




Project Background

- CalWater operated a well on-site starting in 1955
- Groundwater extraction continued until 2016
- Removed 50,000-gallon water storage tank
- Water well, chemical storage enclosures, booster pump, and other amenities remain on-site

Proposed Project

- New groundwater well 1.44 MGD
- 56,000-gal water storage/treatment tank (12-ft tall)
- Three chemical storage enclosures (max 10-ft tall)
- Utility and right-of-way improvements



Proposed Elevation from Carlisle Way (Not to Scale)

Construction

- 3 Months Total Construction Duration:
 - 2 Weeks Continuous Drilling
 - Maximum 1000' depth
 - Noise and Vibration Impacts



CEQA Environmental Review Process

Purpose of CEQA

- Disclose environmental impacts
- Identify and prevent environmental damage
- Provide transparency in the decision-making process
- Enhance public participation
- Foster intergovernmental coordination

Purpose of an EIR

- Inform decision makers and the public about project impacts
- Identify ways to mitigate or avoid impacts
- Identify alternatives to the project

EIR Process Overview and Schedule

- Notice of Preparation (NOP)* / Scoping Meeting*
 - February 3, 2023 March 6, 2023 / February 16, 2023
- Prepare and circulate Draft EIR*
 - Summer 2023
- Prepare and circulate Final EIR/Responses to Comments
 - Fall 2023
- EIR Certification/Public hearings*
 - Early 2024
